




What industry best describes your company?



Why do you conduct drug testing?








Annual budget for drug or alcohol testing




When do you drug test?






What is the total annual amount spent on drug tests by your company?











Pre-employment and random testing compared to 2021







Is fentanyl typically included on a drug test panel for opioids?








What is the total annual volume of alcohol tests performed on employees in your workplace?

















Concerns about legalized marijuana






